TO PAY OR NOT TO PAY? MANAGEMENT OF ARREARS FOR LOCAL PUBLIC SERVICE PROVIDERS

RATIONALE

In the last 25 years policy developments to liberalize and regulate utility markets have been relatively effective in western countries; at the same time emerging countries are facing challenges in terms of investment financing needs, economic sustainability, distributional aspects and welfare implications.

Indeed the aims were to increase competition, boost efficiency, cut prices for final users and promote customer protection, but today these goals are more difficult to achieve by policy makers and firms.

In western countries energy utilities face totally new challenges because of the growing market share of renewables that managed to push wholesale prices down, as did a generally depressed demand with an excess of supply caused by overinvestment in the last 15 years. Water companies in the western world are facing overwhelming problems of underinvestment that sooner or later will be transferred in the final user's charge.

In developing countries, one of the most relevant challenges is to make investments self sustainable with robust revenue streams, and this is valid for both energy and water businesses.

Good revenues for utilities, either energy or water companies, are more difficult to attain today, until a much needed paradigm shift of their business model is developed and tested. Moreover no real reduction of users' charges is foreseen in the short term and thus arrears might contribute to the problem, with strong welfare fall-outs related to vulnerable consumers. Hence the idea to focus a two day course on the subject, from both a private and a public perspective.

TOPICS COVERED

What follows is a list of the most relevant topics that will be covered:

- Regulatory frameworks for fuel poverty and arrears management for water and energy sector
- Policy tools for vulnerable consumers at national and local level
- the role of the Municipality on information and welfare projects
- Corporate financial risk management
- Credit scoring of final users
- Big data analytics for credit scoring and arrears management
- Turin-Index™ toolkit to measure and forecast arrearage

COURSE OBJECTIVES

The course aims to give participants an overview of the regulatory frameworks, corporate consequences and social policy implications, in EU and extra EU, for the management of arrears in sectors such as water and energy, alongside with deep insights from international real case studies presented and discussed among participants.

Corporate participants will be trained on advanced systems to track arrearage at corporate level. Officials from municipalities will learn the fundamentals of the phenomenon in order to develop better welfare actions at local level.

During the course a specific attention will be given to build the proper competence to use the suite of tools called Turin-Index™ developed by the Turin School of Local Regulation (<http://turinschool.eu/turin-index>) useful to increase the quality of final users' credit scoring , to map the arrearage on the caption area of the utility, to forecast arrears on a specific territory and to measure the arrears management in terms of corporate direct costs. Last but not least in order to manage welfare projects on fuel poverty and arrearage management, one short module will be dedicated to the FIELD™ methodology of the Turin School aimed at innovative problem setting.
